3) Review of findings for frequency assignments to stations of terrestrial services recorded in the Master Register (MIFR), pursuant to No. 11.50 of the Radio Regulations (RR)

WRC-15 has modified and suppressed a number of provisions of the RR resulting in changing of allocation situations that require review of findings for the relevant frequency assignments in the MIFR, pursuant to No. **11.50**.

a) Part IIB of this BR IFIC contains 78 frequency assignments recorded in the MIFR to stations of the fixed and the land mobile services of the Administration of Mexico in accordance with Nos. **5.172**, **5.173**, **5.234** and **5.292** of the RR. Due to downgrading of the category of allocation to the fixed and mobile services in the respective bands and in accordance with item 4 of Rules of Procedure on No. **11.50**, the findings of these assignments have been reviewed as follows:

Regulatory finding: favourable
Date of entry into the MIFR: original date kept

Finding observation: S

b) Part IIB of this BR IFIC contains 997 frequency assignments recorded in the MIFR to stations of the fixed and the land mobile services of the Administrations of Germany (49), Greece (1), Kyrgyzstan (278), Lithuania (189), Russia (1), Slovenia (50) and Uzbekistan (429) in accordance with Nos. **5.314**, **5.315** and **5.430A** of the RR. Since the required coordination procedures have not been applied and in accordance with item 5 of Rules of Procedure on No. **11.50**, the findings of these assignments have been reviewed as follows:

Regulatory finding: unfavourable
Date of entry into the MIFR: original date kept

Finding reference: RR8.5 Finding observation: Y

c) Part IIB of this BR IFIC contains 980 frequency assignments to stations of the land mobile service of the Administrations of Argentina (16), Brazil (784) and France (179) recorded in the MIFR on a secondary basis. Due to modification of No. **5.325A** of the RR that resulted in the addition of the primary allocation in the frequency band 902-928 MHz to the land mobile service in these countries, the findings of these assignments have been reviewed as follows:

Regulatory finding: favourable Date of entry into the MIFR: new date

d) Part I of this BR IFIC contains 509 SUPPRESS notices, created by the BR, following the suppression or modification of Nos. **5.98**, **5.119**, **5.166**, **5.201** and **5.430A** of the RR. In accordance with item 3 of Rules of Procedure on No. **11.50**, the corresponding assignments will be suppressed from the MIFR for the following Administrations: Argentina (4), Germany (24), Honduras (2), Mexico (472), New Zealand (5) and Ukraine (2).
