3) Review of findings for frequency assignments to stations of terrestrial services recorded in the Master Register (MIFR) with a reference to No. 4.4 of the Radio Regulations (RR)

The BR has performed a revision of the frequency assignments to terrestrial service stations recorded under No. 4.4 pursuant to No. 14.1 of the RR.
