4) Review of findings for frequency assignments to stations of terrestrial services recorded in the MIFR pursuant to No. 11.50 of the Radio Regulations (RR)

The BR has performed a review of findings for the frequency assignments to stations of terrestrial services, recorded in the MIFR, following the modifications by WRC-23 of a number of provisions of the RR (Nos. **5.155**, **5.201**, **5.359**, **5.429C** and **5.508**) as well as change of the allocation in the frequency band 3600-3800 MHz in Region 1. This review of findings was made in accordance with Rules of Procedure on No. **11.50**. The revised findings are published in the present BR IFIC as detailed below.

a) Part IIB of this BR IFIC contains;

- **4597 frequency assignments recorded in the MIFR to stations of the land mobile service** of the Administrations of Bahrain (12), Egypt (1632), Kazakhstan (64), Kyrgyzstan (1), Lithuania (269), Mongolia (48) and Uzbekistan (2570) related to change of the allocation in the frequency band 3600-3800 MHz in Region 1 and applicable No. **5.434A** of the RR as well as to station of the aeronautical mobile service of the Administration of Belarus (1) related to modification of No. **5.201** of the RR The findings of these assignments have been reviewed as follows:
