**Web Interface for
Submission of Frequency
Assignments/allotment for
Terrestrial Services**

WISFAT

- Resolution 906
 - WRC-07 resolved that, as of 1 January 2009, the submission of notices for terrestrial services to the BR shall be in electronic format only (CR/297)
 - Further revised during WRC-12
- Following this decision, BR developed a secured, reliable and practical way of submitting notices via a web interface
- All notices except notifications for List IV (Coast stations) and List V (Ship stations)

WISFAT

- Secured web site
 - Only registered notifiers can submit via this web interface
 - Administrations nominate their notifier(s)
 - One or many notifier(s) per administration
 - Administrations should inform the BR of any changes regarding the registered notifier(s)
- Reliable system
 - Automatic acknowledgment e-mail is sent by the system as soon as the notices are submitted

How to become a registered notifier?

1. The selected notifier must have a TIES account
 - To request a TIES account via the web:

<http://www.itu.int/TIES/index.html>

- The TIES focal point of your Administration will be contacted by the BR and has to approve your request
2. The administration must send an official e-mail request to the BR (brmail@itu.int)
 - Name, position, service e-mail, TIES Username
 3. BR will inform the notifying administration with the latest list of notifiers

Submission of notices under one of the following procedures of the Radio Regulations (RR)

- Article 9 (Coordination procedure)
- Article 11 (Update of the Master Register)
- Article 12 (HFBC Seasonal Planning)
- Appendix 25 (Allotment Plan - Coast radiotelephone stations - 4000 kHz to 27500 kHz)

Submission of notices in application of a Regional Agreement for update of the Plan

- GE75 (Sound Broadcasting - Regions 1 and 3-LF/MF bands)
- RJ81 (Sound Broadcasting - Region 2 - MF band)
- GE84 (Sound Broadcasting - Regions 1 and part of 3 - 87.5 - 108 MHz)
- GE85-M (Maritime-Mobile / Aeronautical Radionavigation - Region 1 - MF bands)
- GE85-EMA (Maritime radionavigation (radiobeacons-European maritime area - 283.5-315 kHz)
- GE89 (TV Broadcasting - African Broadcasting Area and neighbouring countries - Bands I and III)
- ST61 (TV Broadcasting - European Broadcasting Area - 41-68 MHz, 87.5-100 MHz and 162-174 MHz)
- GE06 (Analogue and digital broadcasting - parts of Regions 1 and 3 - 174-230 MHz and 470-862 MHz)
