GE06 Agreement: General Aspects



- Adopted by the Regional Radiocommunication Conference 15 May–16 June 2006 in Geneva
- Entry into force: 17 June 2007
- Frequency Bands:
 - 174-230 MHz
 - 470-862 MHz
- Planning area:





Region 1:

parts of Region 1 situated to the west of meridian 170° E and to the north of parallel 40° S, except the territory of Mongolia, and in the Islamic Republic of Iran

Plans of the GE06 Agreement



GE06 Agreement contains 3 Plans:

- **Digital Plan** (GE06D)- Assignments and allotments Plan (§3.1.1)
- Analogue Plan (GE06A) Assignments Plan (§3.1.2)
 - o Until 17 June 2015
 - Until 17 June 2020 (for VHF in 34 countries)
- OPS List: existing assignments of Other Primary Services (GE06L) (§1.15)

Situation at the end of RRC06

- Digital: 70 491 assignments/allotments
- Analogue: 94 531 assignments (Source: other plans such as GE89 and ST61 and MIFR)

Current situation (June 2019)

- Digital: 106 397 assignments/allotments
- Analogue: 2 169 assignments



Plan Modification procedure

Article 4 GE06 Agreement

What is a Plan Modification?



Plan modification definition (§ 4.1 and 4.2 of Article 4)

- Change characteristics of an allotment or assignment already in the Plans;
- Add an allotment or assignment to the Plans;
- Add an assignment stemming from an allotment (converted assignment) to the digital Plan;
- Suppress from the Plans an allotment or an assignment.

Allotments in GE06



Allotment: area covered by a Single Frequency Network (SFN) characterized by:

- Type of reference network (RN1, RN2, RN3, RN4)
- Interference envelope: defines the level of interference of the allotment

Assignment stemming from an allotment or converted assignment:

Assignments which are the result of converting an allotment recorded in the Plan into 1 or more assignments. Example: Allotments in Albania for DVB-T in UHF (2011)



Coordination examination and conformity examination



Coordination examination:

Methodology (Section I of Annex 2 of GE06 Agreement) to determine the potentially affected administrations with which coordination is required. This is done for:

- Additions to the Plan
- Modifications to the Plan

Conformity examination:

Methodology (Section II of Annex 4 of GE06 Agreement) to determine if an assignment complies with the Plan. This is done for:

- Converted assignments (assignments stemming from an allotment)
- Assignments notified to the MIFR

Modification procedure: 3 cases





Converted assignments can be notified directly to be recorded in the MIFR without being submitted to the Plan

Key deadlines of Article 4 in GE06



Day 0: Date of publication in Part A

2 years an 75 days (since the publication in Part A): The deadline for a notifying administration to obtain all the agreements from all affected administrations. After this period, if not all agreements were reached, the proposed modifications are suppressed.

75 days (since the publication in Part A): Administrations who did not send their decision (objection or agreement), are considered as "no agreement."

40 Days (affected administration rights):

- § 4.1.3.2: Request the Bureau to add its name to the list of affected administrations
- § 4.1.2.9: Request the Bureau to remove its name from the list of administrations having given their agreement



MIFR Notification procedure

Article 5 GE06 Agreement

GE06 Article **5** = Article **11** Radio Regulations

MIFR notification procedure (GE06)



- GE06 Article 5: when an administration proposes to bring into use an assignment to a station, it shall notify to the Bureau, in accordance with the provisions of Article 11 of the Radio Regulations.
- Before notifying the concerned assignment must be RECORDED in the Plan:
 - **Exception** for the assignment stemming from allotment, which can be notified directly under Article 5

- Open eBCD tools: <u>www.itu.int/ITU-R/eBCD/ebcd.aspx</u>
- Click on eTools
- Access: TIES username and password or Username: user1 Password: user1
- Click on New calculation
- Keep **GE06D Art. 4 Plan Modification**, which by default
- Name your job using the "label your submission" box
- Browse → Choose the file "SUI_example_DVB-T.txt"
- Click on "Upload file"
- Click on "Submit"
- Click on "Back to calculation History" to see the status of your job
- Find your job, and click on Refresh until Job status is 'Success'
- Click on your job Id.
- Click on the Job output
- Click on the "Coordination Exam Result" tab

Exercises on conformity examination under Article 5 of the GE06 Agreement

Procedure

- 1. Open GE06Calc
- 2. Select Tools \rightarrow Conformity examination
- 3. Browse the file and click Next
- 4. Once again click Next and wait for results
- 5. Select item of interest and click on the blue number
- 6. Check the results
- 7. If necessary, modify the notice, using TerRaNotices tool, and repeat steps 2-6

Exercise on compatibility analysis (SUI_example_DVB-T.txt)

<u>Compatibility analysis for a DVB-T/T-DAB assignment or allotment:</u>

- Open eBCD application
- Access: TIES username and password or Username: user1 Password: user1
- Click on eTools
- Click on New calculation
- Select GE06D Compatibility Analyses
- Browse \rightarrow Choose the relating file
- Click on Upload file
- Click on Complete Submission
- Name your job \rightarrow Submit
- Click on Back to calculation History
- Find your job, and click on Refresh until Job status is 'Success'
- Click on View→ Download results
- Save the file on your Disk, Unzip it
- Open GE06Calc→ File→Open Compatibility analysis results file...
