Regulation

- General move to liberalisation
 - increase in (mobile) operators

transparency

- e.g. numbering plans
- change continuing

Number Management Knowledge

- Lack of knowledge of numbering activities
 - Misuse
 - ITU Information (e.g. ITU operational bulletin)
- Change of
 - Responsibilities from Operator to Regulator
 - People

Level of Number Misuse

- Acknowledged level "low" or "not sure"
- Lack of Knowledge or result of ommunications countering activity?
 - Or both?

Role of ITU

- Determined by
 - ITU-T Recommendations for Global resources
 - directly under ITU-T Director's remit e.g. +800, +882
 - Publicise the misuse to counter its continuation
 - Withdrawal of Resources
 - ITU Council Resolution 262
 - The TSB Director will not intervene in any disputes between Member States
 - Geographic resources (e.g. those assigned to countries +44, +61)
 - Notify the Member State (NRA)
 - Provision of technical assistance if requested



What does the ITU do?

- Recommendation E.156 detail the role of the ITU-T
- ITU action on global numbers
 - Direct with the assignee
- ITU action on Geographic resources (e.g. those assigned to countries +44, +61)
 - Notify the Member State (NRA)
 - Provision of technical assistance if requested

Observations are that

- Operators are able to exchange information quicker than regulators
- Operators manage misuse by number blocking



Role of the Member State

- Are the responsibilities clear and legally defined?
- Define the National Numbering Plan (NNP)
 Structure for both international and national
 - Usage what numbers for what services and increasingly where!!
- Rules eligibility, use and powers
- Transparent processes and procedures for the life cycle of the NNP
 - Allocation, reclamation and expansion
- Maintain capacity for existing and new services



Role of Service Providers/Operators

- Are their roles defined?
- Responsibilities
 - One point of contact
 - Active monitoring
 - Corporate responsibility
 - Maintain up to date and accessible records
- Number Management Processes
 - Documented for life cycle and operations
 - Active Monitoring of use and of abuse
- Use of Contracts
- Sharing information



Recommendations

- Self Assessment?
 - Does the national regulatory framework do its job?
 - Audit of operators?
 - Enforcement Powers?
 - Flexibility?
 - Clarity and Understanding of numbers?
 - Management of Numbers
 - Records?
 - Processes?
 - Sufficient capacity?
 - Meeting new demands?
- Role of commercial arrangements to counter misuse
- Possible for SG2 to develop a checklist

Next Steps

- Self Assessment by the NRA
- Training
 - Simple (what are numbers, how are they managed) to the complex (what constitutes misuse, options to counter)
- Utilise through ITU T SG2
 - Identify a contact point in NRA's to assist in incidents of misuse of national numbers
 - ITU Move from receiving reports of national number misuse to distribution of incidents
 - Individual experts participate and contribute
