## 4 Review of input documents and follow-up actions

#### 4.1 Broadcasting terms

**Document SCV** <u>TD 23</u>: Reply from ITU-T SG 16 to SCV - LS on broadcasting terms and definitions

The document was presented. As the original liaison statement from the SCV (Doc. SCV-LS5) was sent to both ITU-T SG 9 and ITU-T SG 16 for action, it was mentioned that both SGs 9 and 16 should first discuss and decide on the most appropriate definitions within ITU-T and inform ITU-R SG 6 accordingly. It was further mentioned that it is possible to have multiple definitions for different applications/contexts. After some discussion, it was finally suggested and agreed that ITU-T SG 9 would coordinate with ITU-T SG 16 regarding all terms and definitions before sending its reply and SCV/CCV would wait the reply from ITU-T SG 9 before taking any further action.
