Title:	Report of the 1 June 2017 joint SCV-CCV conference call meeting			

1 **Opening remarks**

Mr. C. Rissone, Chairman of the CCV, and Ms. R. Belhaj, Chairman of the SCV, welcomed the participants and opened the meeting. Annex 1 contains the list of participants to the meeting.

2 Approval of the agenda

The draft agenda was presented and approved.

3 Summary record of the last CCV/SCV conference call meeting

Document CCV/26 (+ Add.1) - SCV TD 57 (+ Add.1): Summary record of the joint CCV-SCV conference call meeting on 18 January 2017

The document was presented. No comments were provided and the document was approved.

4 **Review of input documents and follow-up actions**

4.1 Proposed merge of Resolutions ITU-R 34, 35 and 36

Document CCV/26 (Add.1) - SCV TD 57 (Add.1): Proposed merge of Resolutions ITU-R 34-4, ITU-R 35-4 and ITU-R 36-4.

The document was considered. Comments were made regarding the consideration or otherwise of the recently adopted Council Resolution 1386 on the ITU Coordination Committee for Terminology (ITU CCT). The meeting agreed that the document be kept as an addendum to this summary record in order to be revisited at the next meeting (see Addendum 1).

4.2 **Broadband definition**

Document CCV/27: Liaison statement from ITU-R Working Party 5D – Broadband access technologies, including IMT, for developing countries. What is the definition of Broadband?

The document was considered. It was mentioned that during the recent meetings of the various ITU-R working parties involved in this discussion no objection or adverse comments were made with regard to the proposed definition of the term "broadband access". Nevertheless, it was suggested that this issue should be discussed and agreed more widely including ITU-T and ITU-D.

The meeting agreed to send another liaison statement to the concerned ITU-T and ITU-D study groups mentioning that ITU-R has agreed with the proposed definition of the term "broadband access" and asking their views.

4.3 Further considerations on the translation into other languages of descriptive terms used in subjective evaluation methods

Document CCV/28: Liaison statement from ITU-R Working Party 6C – Further considerations on the translation into other languages of descriptive terms used in subjective evaluation methods

The document was presented. It was mentioned that the responsibility for carefully choosing descriptive terms used in subjective evaluation methods lies with the organizers of subjective tests. In that regard, it was further mentioned that an input contribution to ITU-R Working Party 6C would be prepared in order to include an informative annex to Recommendation ITU-R BT.500 providing guidelines for organizers of subjective tests on what should be mentioned to the assessors.

In view of the above, the document was noted and the meeting agreed that no liaison statement should be sent to ITU-R Working Party 6C at this point in time. Further studies are expected in order to bring a solution to this issue.

4.4 Proposal to add broadcasting terms to the database

Document CCV/29: Liaison statement from ITU-R Study Group 6 – Terms, acronyms and definitions

The document was presented. The meeting noted with satisfaction that term "digital divide" and its definition (as approved by the CCV/SCV) are included in an editorial revision to Recommendation ITU-R BT.1832 which could therefore now be shown in the ITU terminology database as the "source" for the term "digital divide". In reply to a question raised, the meeting was informed that the "source" for the terms "Digital switchover" and "Digital dividend" would be confirmed later on.

It was further mentioned that, as agreed at the previous meeting, those three terms and definitions will be moved to Part 2 of the ITU terminology database if no further comments/suggestions are received from ITU-R Working Party 1B after its next meeting in June 2017.

The meeting agreed to include in Part 3 of the ITU terminology database the term "pixel" and its definition as proposed in the document.

Concerning the term "Chromaticity", it was mentioned that it would be preferable to have an ITU-R Recommendation or Report as the source for the term and its definition. It was further mentioned that in fact the term "Chroma" is used within ITU-R and that ITU-R Study Group 6 would further study the use of the term "Chroma" and the definition currently included in the ITU terminology database coming from Recommendation ITU-T T.832 (2016): "A component of the primary image plane with non-zero index or the transform coefficients and sample values associated with this component".

With regard to the terms provided in Table 2 of the document, the meeting agreed to include in Part 3 of the ITU terminology database the term "MPEG media transport" together with its acronym and definition as proposed.

It was mentioned that the terms "Advanced common application platform", "Consumer Electronics Association", "Open IPTV Forum" and "World Wide Web Consortium" were not appropriate to be included in the ITU terminology database, as these are not technical terms.

It was further mentioned that ITU-R Study Group 6 would further study the use of the terms "Declarative application environment", "Digital rights management" and "Dynamic adaptive streaming over HTTP" and the corresponding definitions and acronyms currently included in the ITU terminology database coming from Recommendations ITU-T J.296 (2012): "Declarative application environment: An application environment using HTML", ITU-T X.1193 (2011) "Digital rights management: A synonym for service and content protection or content protection, depending upon the context of use.", and ITU-T G.1022 (2016), "Dynamic adaptive streaming over HTTP:

Dynamic adaptive streaming over HTTP is the first adaptive streaming solution which has become an International Standard", respectively.

It was further suggested that the agreed definitions should be included in a revised version of Recommendation ITU-R BT.2075-1, similarly to the course of action taken with regard to the term "digital divide".

The meeting agreed to send a liaison statement to ITU-R Study Group 6 seeking its views on the above comments and suggestions.

4.5 Terms and definitions harmonization

Document CCV/30: Liaison statement from ITU-T Study Group 2 on terms and definitions harmonization

The document was considered and noted.

4.6 French and Spanish translations and definitions of "Secondary distribution" in the ITU Terminology Database

Document CCV/31: Contribution from Italy – On the French and Spanish translations and definitions of "secondary distribution" in the ITU Terminology Database

The document was presented. It was mentioned that the term "secondary distribution link" is included in the ITU terminology database with appropriate translations and definitions in the six official ITU languages.

As the subject French and Spanish translations and definitions of the term "secondary distribution" in the ITU Terminology Database were provided by ITU-T, the meeting agreed that TSB/ITU-T should further investigate and possibly supress that entry from the ITU terminology database.

4.7 Explanation of the term "Jam Strobe"

Document CCV/32: Liaison statement from ITU-R Working Party 5B – Reply to the Coordination Committee for Vocabulary on the explanation of the term "Jam strobe"

The document was presented. It was suggested to amend the definition to read "a technique to identify interferences into a radar receiver displaying a visible radial line identifying the direction of sources of certain kinds of interference". The meeting agreed with that suggestion and to include in Part 3 of the ITU terminology database the term "Jam strobe" with and the above amended definition. The meeting further agreed to send a liaison statement to ITU-R Working Party 5B accordingly.

4.8 SCV vocabulary rapporteurs appointed by ITU-T study groups for the 2017-2020 study period

Document SCV-TD 59: Contribution from SCV Secretariat – Vocabulary rapporteurs appointed for the 2017-2020 study period

The document was considered. The meeting noted the excellent response from the ITU-T study groups and welcomed the new vocabulary rapporteurs.

4.9 LS from ITU-T SG3 on intention to check for overlaps between its activities and those of ITU-T SG2

Document SCV-TD 60: Liaison statement from ITU-T Study Group 3 on ITU-T study group responsibilities in WTSA Resolution 67 (Rev. Dubai, 2012) – Terms and Definitions harmonization

The document was considered. The meeting noted with thanks the information provided.

4.10 ITU Coordination Committee for Terminology (CCT)

Document C17/**127:** Council Resolution 1386 – ITU Coordination Committee for Terminology (ITU CCT)

The document was presented. In reply to a question raised, the meeting was informed that Council Resolution 1386 is already in force. It was suggested and agreed by the meeting that Document C17/127 be kept as an addendum to this summary record (see Addendum 2). The next meeting of the Council Working Group on the use of the six official languages of the Union (CWG-LANG) will take place during the 15-26 January 2018 Cluster of Council Working Groups, and Council 2018 will take place 17-27 April 2018.

5 ITU terminology database – follow-up

Document CCV/4(Rev.4): Terms, acronyms and definitions in Part 3 of the ITU terminology database

The document was presented. As usual, an updated version of the document will be prepared reflecting the decisions of the meeting. The meeting was informed of the progress made in the development of improvements and new applications for incorporation in the ITU terminology database.

6 Next SCV-CCV conference call meeting

The meeting agreed that the next SCV-CCV conference call meeting will take place on 23 November 2017 at 14:00 hours (Geneva time).

7 Any other business

There was no other business.

8 Closing remarks

The Chairmen thanked all the participants for their collaboration as well as the TSB and BR Secretariat, in particular Mr. Anibal Cabrera and Mr. Nelson Malaguti.
