3. Tokenized fiat money – Minted by authorized financial institutions. Regulatory compliant. KYC and AML process. E-money token standard.



1. Public-permissioned networks – Open, decentralized, multipurpose, multicommunity, scalable, regulated, with identification, and transaction fee free.






#### LACChain as a quantum-safe network of networks




