Mr. Prado has been participating on ITU-T Study Group 12 activities in the last study period, especially in the work led by Question 12/12 and the Quality of Service Development Group – QSDG (where he is vice-chairman) focused in promoting an international debate on QoS/QoE regulatory frameworks and in raising awareness on the importance to provide better service quality to the end users. He is also leading the work of creating an ITU-T Recommendation on QoS measurement in Major Events, like World Cups and Olympic Games (ITU-T Draft Recommendation E.QMME). He was also the Editor of the Recommendation Y.3035 (“Service Universalization in Future Networks”), on ITU-T Study Group 13 that leads to raise awareness of the importance to develop new technologies economically sustainable. Besides, he frequently participates in Brazilian delegations (in many cases as Head of Delegation) on relevant conferences, as the ITU World Telecommunication Standardization Assembly – WTSA, ITU World Conference on International Telecommunication – WCIT, ITU-T SG 2 and SG 13 meetings and the OAS/CITEL Permanent Consultative Committee I: Telecommunications/ICT meetings.

Professional Experience:

Mr. Prado works at National Telecommunications Agency – Anatel, the Brazilian telecommunication regulatory authority, since 2011 as adviser on planning and implementing ICT public policies, mainly the Broadband National Plan, by fostering the deployment of telecommunication/ICT infrastructure and competition in the provision of broadband services. He has been focusing his work in the development of regulatory solutions that enable investments and tackle telecommunication infrastructure challenges in Brazil, especially in terms of raising coverage, quality and competition in fixed and mobile broadband service provision. He is also one of the Anatel's specialists in the field of spectrum pricing and spectrum auctioning for enhancing the provision of broadband services. He worked also at the ICT department of Bank of Brazil S.A as ICT Advisor, managing modernization of ICT business platforms at several branches around the world (mainly at US, Europe, South America and Japan).
