	• Article 12 - RR1228 (RRB97/46(Rev.1), RRB97/51, Doc. 9B/TEMP/38(Rev.1))	The draft Rule of Procedure concerning RR1228 was approved, as modified (Document RRB97/46(Rev.2)). Pending a final decision by WRC-97, the Rule is provisional and will be reviewed after WRC-97.	
	• Article 12 - RR1245 (RRB97/47)	Review of RR1245 was approved, as modified (the word "respectively" removed at the end of para. 3). The above-mentioned revisions to the Rules of Procedure will be published in a BR Circular-letter	Director/TSD
