

Terms and Conditions for the Generation Connect Gender Champion Competition

- 1. The Generation Connect Gender Champion Competition (the "Competition") is organized by the International Telecommunication Union ("ITU" or the "Organizer"). By submitting your application form for participation in the Competition, you accept the present terms and conditions.
- 2. You hereby warrant that all information submitted is true, complete, and up-to-date. You represent that you are at least 18 years of age and maximum 24 years of age at the time of submitting your application form for participation in the Competition.
- 3. You represent that you are not related to any of the members of the Competition's selection committee, and that neither you nor any members of your family (up to the third degree) are employed by the Organizer. The Organizer reserves the right to verify your eligibility for participation in the Competition as well as the accuracy of your submitted information.
- 4. The Organizer reserves the right in its sole discretion to disqualify you if it reasonably considers that the information you have provided and/or your submissions do not comply with the terms, instructions and guidelines provided in the <u>Competition website</u>, the application form, as well as the present terms and conditions. By way of example, submissions which are not in English or which the Organizer deems to be off topic or otherwise not in accordance with the nature of the Competition or the mission of the Organizer are subject to disqualification.
- 5. The selection of the 12 Generation Connect Gender Champions will be made by a selection committee and communicated via email and on the Competition website.
- 6. The 12 Generation Connect Gender Champions will be required to attend the ITU Generation Connect Youth Summit ("Youth Summit") on 2-4 June 2022 in Kigali, Rwanda. In this context, the Organizer will provide the 12 Champions with (i) a round trip economy flight ticket to/from the location, (ii) health and accident insurance coverage for the duration of the Youth Summit and (iii) accommodation and per diem subsistence allowance for the duration of the Youth Summit.
- 7. Notwithstanding the previous section, the selected 12 Generation Connect Gender Champions shall be responsible for defraying all other costs and expenses arising from or relating to their participation in the Youth Summit, including any travel or accommodation costs not covered by the reward mentioned in the previous section. Moreover, the selected 12 Generation Connect Gender Champions are solely responsible for meeting all necessary visa requirements and having all necessary travel documentation in order prior to travel.

- 8. No substitution or transfer of the above-mentioned reward by 12 Generation Connect Gender Champions is permitted.
- 9. You permit the Organizer to use your name, likeness, video and/or photograph in connection with the Competition, in any media, worldwide, at no remuneration.
- 10. You understand and agree that the Organizer may create content based on your participation in the Competition and your submission, such as blog posts, photos or social media postings which may be published on the Organizer's websites and other communication channels and made available to the public, at the Organizer's discretion.
- 11. You are not allowed to use the Organizer emblem or the logos of any Organizer events without the prior written permission of the Organizer.
- 12. All submissions must not: a. violate the intellectual property rights of third parties; b. be illegal under applicable national laws and international law; c. depict or incite hatred, defame, abuse, harass, stalk, threaten a specific person or social group, incite violence or conflict or otherwise violate the legal rights of third parties (including those of privacy and publicity) and d. violate the terms of use of any social media service, website, mobile application or any other platform used in connection with your submission. You agree to release and hold harmless the Organizer from and against any and all claims, expenses, and liability arising out of or relating to your participation in the Competition and the content of your submissions.
- 13. You acknowledge and agree that your participation in the Competition is free of charge but does not entail any right to compensation of any kind or to reimbursement of any expenses incurred from such participation.
- 14. The Organizer is not responsible for any lost, late, corrupted, mutilated or misdirected submissions, or submissions not received within the established deadlines.
- 15. You acknowledge and agree that the Organizer is entitled to modify the content of the Competition and/or the present terms and conditions and to abbreviate, modify, suspend, cancel or terminate the Competition (in whole, or in part) without any obligation, by notifying you via an announcement at the Competition website.
- 16. The Organizer reserves the right to make all final decisions regarding the Competition. Nothing herein shall be considered to be a limitation or a waiver of the privileges and immunities of the Organizer, which are specifically reserved.
