**Subject: Regional Development Forum (RDF-CIS), 23 April 2025, and Regional Preparatory Meeting for the Commonwealth of Independent States region (RPM-CIS), 24-25 April 2025, Bishkek, Kyrgyzstan**

Dear Sir/Madam,

I am pleased to invite you to participate in the Regional Preparatory Meeting for the Commonwealth of Independent States region (RPM-CIS), to be held from 24-25 April 2025, in preparation for the World Telecommunication Development Conference (WTDC-25) which will take place in Baku, Azerbaijan from 17 to 28 November 2025 at the kind invitation of the Government of Azerbaijan.

The RPM-CIS will be preceded by the Regional Development Forum for the Commonwealth of Independent States region (RDF-CIS) at the same venue, on 23 April 2025.

In line with Resolution 31 (Rev. Kigali, 2022), the Regional Preparatory Meeting aims at engaging the Membership in the WTDC-25 process in order to achieve regional coordination before the Conference. It also seeks to identify issues at the regional level, that need to be addressed to foster the development of telecommunications/ICTs, taking into account the most pressing needs faced by the Member States and Sector Members of the region.

RPM-CIS will provide a platform for identifying priority areas which are essential for the telecommunication/ICT development of the countries of the region. To this end, and to facilitate effective preparations by the ITU Membership, a draft RPM-CIS agenda has been prepared and can be found in **Annex 1**.

Members participating in this RPM meeting will also be able to review and provide input on the preliminary draft ITU-D contribution to the ITU Strategic Plan for 2028-2031, the preliminary draft ITU-D Action Plan 2026-2030, and the preliminary draft WTDC-25 Declaration ahead of WTDC-25. These documents, which will be available on the [RPM-CIS website](#), are intended to assist in the written formulation of the issues and priorities for each of the regions.

On 23 April 2025, the RDF-CIS will provide an opportunity for high-level dialogue, cooperation and partnerships among telecommunication/ICT policy makers, regulators, industry, academia, regional and international development agencies and organizations on specific regional telecommunication/ICT issues. RDFs serve as a platform for assessing strategic orientations that may have an impact on the regional work plan of the Telecommunication Development Bureau (BDT) in between world telecommunication development conferences. A draft RDF-CIS agenda has been prepared and can be found in **Annex 2**.

**Annex 3** to this letter provides detailed information about key deadlines for submission of contributions, for registration and remote participation, for fellowships and for all the basic information to allow you to participate and make the best of these two events. Practical information will be posted on the event website in due course.

To request a fellowship, the participant must **first** [register to the meeting\(s\)](#) and **obtain focal point approval**. Any application received after this deadline will not be considered.
