





Implementing the Decision

| Scope of Application : .KR

| Key circumstances in **complaint-I**

1. If the Respondent's use of the domain name infringes upon the Complainant's rights to the trademark or service mark registered in Korea;
2. If the Respondent's use of the domain name causes confusion with the Complainant's goods or services that are widely known in Korea;

| Key circumstances in **complaint** -II

3. If the Respondent's use of the domain name damages the distinctiveness or reputation of the Complainant's personal name, trademark, service mark or trade name that is widely known in Korea; or
4. If the Respondent's domain name is identical with or similar to the Complainant's personal name, trademark, service mark or trade name that is **widely known** domestically or **internationally**, and the Respondent's main purpose for registering the domain name is to interfere with the Complainant's registration of his/her personal name, trademark, service mark or trade name as a domain name.

| Key circumstances in **response**

The Panel may determine that the Complainant's rights or legitimate interest is not infringed,

in case domain name is

- non-distinctive
- under legitimate use
- identical with the personal name, title, trademark, service mark or trade name, to which he/she has legitimate rights.



- ? Decision may be disclosed
- ? Remedies are limited to “**CANCELLATION**” or “**TRANSFER**”
of the domain name
(No compensation for damages)
- ? Decisions are not binding, and can be brought to a
court anytime
- ? **Maintaining the Status Quo**
from the date of commencement of the dispute resolution
procedure to the date of closure of the dispute resolution
procedure

Pre-stage

restricted names(categories, indecent words, etc.)

1st Stage

reserved names for public/governmental organization

2nd Stage

Prior registration for Trademark/Trade name holders


3rd Stage

One registration per one certificate of residence


4th Stage




Statistics (2) KR composition percentage in Jan. 2003




Current Status(3) Yearly IP counts(1990-2002)




Statistics(4) – Regional distribution in Jan. 2003




Current Status(5) - Yearly ASN counts in Jan. 2003



Current Status(6)-ISP member





Current Status(6)-Number of Internet Users




Current Status(7)-Internet Penetration Rate (by Sex)






Current Status(8)-KRNIC Network
