To the Director General

Dear Sir/Madam,

- In accordance with the schedule of the intersessional activities established by the first session of the Regional Radiocommunication Conference for planning of the digital terrestrial broadcasting service in parts of Regions 1 and 3, in the frequency bands 174-230 MHz and 470-862 MHz (RRC-04), as contained in Annex 2 to Resolution COM5/1, which was held in Geneva from 10 to 28 May 2004, the Radiocommunication Bureau issued Circular Letter CR/241 of 29 July 2005, by which it invited your Administration to submit its digital broadcasting requirements to be used for the preparation of the draft Plan, by 31 October 2005. The relevant electronic format for submission of these requirements, as amended to reflect the decisions of the IPG-1 meeting (4–8 July 2005) has been described in BR Circular Letter CR/242 of 29 July 2005.
- In response to Circular Letter CR/241, 109 Member States from the planning area and one observer (the Palestinian Authority) have submitted their requirements for the draft Plan within the time limit established by the RRC-04. In addition, the Bureau received guidance from three Member States on the course of action that should be followed in their respect, notably:

¹ This Circular Letter is primarily addressed to the Member States of Region 1 (except Mongolia) and to the Islamic Republic of Iran. It is for information only for other Member States.

- 2.1 The administration of Angola requested the Bureau to generate digital requirements for Angola, by converting the relevant analogue broadcasting assignments of Angola, as they appear in the updated version of the GE89 Plan.
- 2.2 The administrations of Iceland and Seychelles informed the Bureau that they considered it unnecessary to submit any digital requirements for the draft Plan, given their geographical situations and the envisaged characteristics of their digital broadcasting stations. In addition, the two administrations requested the Bureau and the Planning Exercise Team (PXT) not to generate any digital broadcasting requirements on their behalf.
- The Bureau received no digital requirements and no replies to the relevant reminders from the following Member States: GNE, LBR, MWI, RRW, SOM, SRL and STP. With respect to these Member States, the following course of action has been followed:
- 3.1 Given the fact that the administration of Malawi submitted requirements for the first planning exercise, the Bureau followed the indications in §6.2 of the Report from RRC-04, and the requirements of MWI submitted for the first planning exercise are also used for the production of the draft Plan
- 3.2 Using the approach applied in the case of Angola (conversion of their analogue television assignments into digital television broadcasting requirements), the PXT applied a similar approach for those Member States that did not submit digital broadcasting requirements: GNE, LBR, RRW, SOM, SRL and STP.
- It is recalled that the Bureau published the complete requirements file of a given administration, on the dedicated web page, immediately after its validation (with the understanding that the fields relating to the conversion from analogue television assignments to digital television requirements, where applicable, would need to be re-validated after the establishment of the reference situation for the analogue television broadcasting). For instance, the requirements of 79 administrations (including the relevant corrections, where needed) had already been published by 11 November 2005, and the initial publication of all requirements received by the administrations was completed on 19 December 2005. Such a course of action provided possibilities to all administrations to review their own requirements as well as the requirements from the other concerned administrations in a timely manner and to proceed with the submission of the relevant administrative declarations, where necessary. After the establishment of the reference situation for the analogue television broadcasting, all the requirements have been re-validated and the resulting situation is included in the attached CD-ROM. The resulting situation takes account of the requirements withdrawn by administrations by 24 December 2005. Summary information on the received digital broadcasting requirements for the draft Plan is provided in Annex 1 to this Circular Letter.
- 5 The attached CD-ROM also contains data for existing and planned analogue television broadcasting assignments and existing and planned assignments of other primary services; this data have been retrieved from the relevant files as indicated in §1.7 of the Report from RRC-04. In this connection, the Bureau wishes to indicate the following:
- 5.1 With respect to the analogue television broadcasting assignments that relate to stations situated in those parts of the planning area that are covered by the ST61 or the GE89 Agreements, the Bureau wishes to report that it received, on 31 October 2005 (e.g., on the last day referred to in §1.7 of the Report), more than 8 000 proposals for the modification to the ST61 Plan from one single administration. Given the fact that some of these proposals were eligible for inclusion in the reference situation (in terms of the applicable procedures of the ST61 Agreement and the decisions of the RRC-04), the Bureau conducted promptly all required activities, with a view to timely processing of these notices. Given the amount of data to be processed and the associated correspondence and examinations, the processing of these data took a substantive time and the

relevant Special Sections (ST61/1510 and ST61/1511) were published on 10 and 24 January 2006, respectively (see BRIFIC Nos. 2560 and 2561).

- 5.2 Concerning the analogue broadcasting assignments submitted by Iraq by 28 August 2004, 21 frequency assignments have been successfully coordinated with all administrations concerned under the procedure of the GE89 Agreement and have been included in the reference situation. The remaining uncoordinated assignments will be submitted to RRC-06 for consideration and further action, as appropriate.
- 5.3 With respect to the analogue television broadcasting assignments that relate to stations situated in those parts of the planning area that are not covered by the ST61 or the GE89 Agreements, the Bureau wishes to report that it received, on 29 October 2005, an updated list of these assignments, which superseded the "RCC List" that was attached to Circular Letter CR/209. Given the amount of data to be processed and the associated correspondence and examinations, the processing of these data took a substantive time and was completed on 23 December 2005.
- With respect to analogue television broadcasting assignments to be taken into consideration in the planning process, the Bureau issued Circular Letter CR/244 (dated 28 September 2005) in which it invited the administrations of the Member States from the planning area to give consideration to their analogue television broadcasting assignments that are eligible for inclusion in the reference situation for the production of the draft Plan with a view to initiating the necessary actions, where appropriate. In this respect, the Bureau received indications from 44 administrations providing information on the course of action to be followed with respect to their analogue television broadcasting assignments in the context of the compatibility assessment associated with the draft Plan. In this context, 38 Member States requested the Bureau to exclude all their analogue television broadcasting assignments from the compatibility assessment process associated with the draft Plan and 6 Member States requested exclusion of some of their analogue television broadcasting assignments. For the remaining 75 Member States, which did not provide any information in this respect, it is assumed, in terms of the decisions of RRC-04, that all of their eligible assignments to analogue television broadcasting will be included in the compatibility assessment process associated with the draft Plan. Information on the administrations that requested complete or partial exclusion of their analogue television broadcasting assignments from the compatibility assessment process associated with the draft Plan is provided in Annex 2 to this Circular Letter.
- be taken into consideration in the planning process, the Bureau issued Circular Letter CR/243 (dated 19 September 2005) in which it invited the administrations of the Member States from the planning area to give consideration to their assignments in the primary terrestrial services other than broadcasting, that are eligible for inclusion in the reference situation for the production of the draft Plan, with a view to initiating the necessary actions where appropriate. In this respect, the Bureau received information from 19 administrations on the course of action to be followed with respect to their assignments in the primary terrestrial services other than broadcasting, in the bands 174–230 MHz and 470–862 MHz, in the context of the compatibility assessment associated with the draft Plan. Summary information on these requests is provided in Annex 3 to this Circular Letter.

- All information regarding the input data that will be used for production of the draft Plan (i.e., digital broadcasting requirements, data concerning the analogue television broadcasting, data concerning the other primary services) has been consolidated and is included in the attached CD-ROM. The CD-ROM also contains the Data Display application (RRC06Display2), which allows administrations to view the particulars of the input data. This display application also has a feature, called "Administrative Declaration Tool" which can be used to prepare declaration files to be submitted to the Bureau. Guidelines for preparation of the administrative declarations have been made available on the ITU web site (see http://www.itu.int/ITU-R/conferences/rrc/rrc-04/intersession/draft_plan/Data/Guide_for_creating_administrative_declarations.pps)

ANNEX 2

Summary information regarding the analogue television broadcasting

1. The Report from RRC-04 contains, in §1.7, indications on the eligible assignments for inclusion in the reference situation. Some 44 administrations requested explicitly, through general statements or through forms of notice BC6, exclusion of some of their eligible assignments to analogue television broadcasting from the compatibility assessment process associated with the draft Plan. The summary information regarding the analogue television broadcasting is presented in the following Table:

- 3. The following administrations requested exclusion of some of their analogue television broadcasting assignments from the compatibility assessment process associated with the draft Plan:
 - CTI (exclusion of all analogue TV assignments in the band 470–862 MHz);
 - HRV (exclusion of assignments as indicated in the BC6 notices);
 - IRN (exclusion of all VHF assignments whose e.r.p is equal to or below 14 dBW and all UHF assignments whose e.r.p. is equal to or below 17 dBW);
 - KEN (exclusion of assignments as indicated in the BC6 notices and all assignments above channel 62);
 - SUI (exclusion of assignments except those as indicated in the BC6 notices);
 - TUR (exclusion of assignments as indicated in the BC6 notices).

ANNEX 3

Summary information regarding the existing and planned assignments to other primary terrestrial services

- 1. On 31 October 2005, the MIFR contained 25 987 recorded assignments to primary terrestrial services other than broadcasting, from 54 administrations in the planning area. Out of these data, there were 20 624 assignments eligible for inclusion into the reference situation, from 41 administrations.
- 2. Some 14 administrations requested explicitly through forms of notice R06 the inclusion of some of their existing and planned assignments to other primary terrestrial services in the compatibility assessment process associated with the draft Plan. The concerned assignments have been examined from the view point of their compliance with the criteria established by RRC-04, including the compliance with the coordination requirements (for the assignments notified after 10 May 2004). Some of the assignments, for which inclusion was requested, could not be included into the reference situation due to disagreement from potentially affected administrations or due to missing or incomplete coordination information. The summary information regarding the requests for inclusion and the included assignments is presented in the following Table:

3. The administrations of D, ISL, MDA, POL and UKR, which had assignments eligible for inclusion into the reference situation, indicated to the Bureau that their existing and planned assignments to other primary terrestrial services should not be considered in the compatibility assessment process associated with the establishment of the draft Plan. Similar statements were received from the administrations of AND, CZE, E and KEN, which have assignments recorded in the MIFR, but which are not eligible for inclusion into the reference situation.
