Subject: Rules of Procedure approved by the Radio Regulations Board.

To the Director-General

Dear Madam/Sir,

1 Pursuant to the provisions of Nos. 13.12 and 13.14 of the Radio Regulations, the Radio Regulations Board (RRB) at its 35th meeting (6 – 10 December 2004) approved new or modified Rules of Procedure. The majority of these changes to the Rules of Procedure are related to the decisions of WRC-03.

2 The new or modified Rules of Procedure are included in the attached replacement pages for the recently published volume (the 2002 edition of the Rules of Procedure, referred to in CR/187). The replacement pages indicate where the changes have been made by a cross-reference in parenthesis to the RRB Document number in which the decision appears. All of the new Rules or modifications to existing Rules listed below take effect immediately, except where indicated. The modifications are as noted below:

2.1 Modification of the Rule of Procedure relating to No. **9.11A** of Article **9** (**Table 9.11A-1**) of the Radio Regulations.

2.2 Modification of the Rule of Procedure relating to No. **9.27** of Article **9** of the Radio Regulations.

2.3 Modification of the Rule of Procedure relating to No. **11.31** of Article **11** of the Radio Regulations.

2.4 Modification of the Rule of Procedure (Part **B**, Section **B3**) relating to the calculation of probability of harmful interference between space networks (C/I ratios).

2.5 Modification of the Rule of Procedure relating to No. **11.32** of Article **11** of the Radio Regulations and suppression of the Rule of Procedure relating to No. **5.392** of Article **5** of the Radio Regulations.

3 The attached replacement pages also provide corrections to previously distributed updates to the Rules of Procedure. These corrections are :

3.1 Modification of incorrect title 5.466A to the correct title 5.446A, this new Rule of Procedure having been approved at the 33rd meeting of the RRB.

3.2 Correction of a value provided in the Rule of Procedure related to 5.503, which was approved at the 34th meeting of the RRB.

3.3 Correction to paragraph 1 of the Rule of Procedure relating to Article 8 of Appendix 30B; this new Rule of Procedure was approved at the 34th meeting of the RRB.
