#### Call for contributions

The principal objectives for the fourth meeting of JTG 5-6 are:

- (i) to finalize consideration of the results of sharing studies between the mobile service, on the one hand, and other services, on the other hand, in the band 790-862 MHz
- (ii) to identify method(s) to satisfy WRC-11 Agenda item 1.17 and
- (iii) to commence development of the JTG 5-6 Report on sharing studies in response to Resolution 749.

In particular, the following issues are considered very important, to be dealt by JTG 5-6 through further contributions to the next meeting:

- Sharing studies between the mobile service and other primary services in the band 790-862 MHz should be further pursued and their results need to be analysed. The existing draft CPM text in Section 3/1.17/4 requires careful reviewing to reflect properly the results of the studies.
- It has to be noted that there was no contribution from administrations on the methodology for the studies between the fixed service and the mobile service during the third meeting of JTG 5-6. Administrations are therefore invited to submit contributions for the preparation of CPM text for the next meeting of JTG 5-6 (Section 3/1.17/4.3).
- The Report should be collated from the information provided in documents as contributions toward the sharing studies in response to Resolution **749** (WRC-07). The Rapporteur, according to the Terms of Reference, will liaise with the Chairman of JTG 5-6 and the Chairmen of the Sub-Working Groups in the preparation of the layout of the Report and its contents. The Terms of Reference for the Rapporteur's activity are given in Document 5-6/89.
- Method(s) to satisfy the agenda item should be identified based on the results of sharing studies. The text for Section 3/1.17/5 of the draft CPM Report needs to be prepared to present the proposed method(s).

Participants in the work of JTG 5-6 are strongly encouraged to submit contributions to the next meeting of JTG 5-6 noting the guidance provided by the list above. This applies equally to Regions 1 and 3 countries.
