Subject: Second meeting of the Working Party of the Special Committee on Regulatory/Procedural matters in preparation for the WRC-07

Introduction

Following the WRC-03 decisions and in accordance with the work programme of the Conference Preparatory Meeting (CPM 06-1), established in July 2003 it was agreed, that the Working Party of the Special Committee (WP-SC) will hold two meetings, namely, in the second part of 2004 and in the second part of 2005. The first meeting was held in Geneva from 22 to 27 October 2004.

The second meeting will be held from 30 November to 5 December 2005 at the ITU premises. The delegate registration, document distribution and other related services will be located in the vicinity of the meeting rooms. The opening session will take place at 10:00 hours and registration of delegates will start at 08:30 hours on 30 November 2005.

Contributions in response to the WP-SC draft agenda (Annex 1) are invited. The Working Group will conduct its work in English.

Resolution ITU R 1-4 provides that contributions which are not available to participants at the opening of the meeting shall not be considered.

Visa requirements

We would remind you that citizens of some countries are required to obtain a visa in order to enter and spend any time in Switzerland. The visa must be requested and obtained from the office (embassy or consulate) representing Switzerland in your country or, if there is no such office in your country, from the one that is closest to the country of departure. If problems are encountered, the Union can, at the official request of the administration or company you represent, approach the competent Swiss authorities in order to facilitate delivery of the visa.

Visa requests should be made via an official covering letter from the administration or company you represent. This letter must specify your name and function, date of birth, passport number as well as the date of issuance and expiration. The letter must be accompanied by a photocopy of your passport and completed registration form and must be sent by fax to the ITU-R Document and Meetings Unit, Office V.434, Attention: Mrs. L. Kocher. The fax number is +41 22 730 6600. Please note that the Union needs at least one week to process all papers required for the delivery of a visa.
