2) Please replace the description of data item "rrc_coord_self", contained in Annex 7 to Circular Letter CR/242 of 29 July 2005, by the following:

Data item	Description and validation rules
rrc_coord_self	Optional. Indicator concerning the internal compatibility of the requirement with respect to all other assignments/requirements of the notifying administration (analogue TV assignments and/or assignments of other primary services). Acceptable values are TRUE or FALSE.

These changes are clarifying the scope of the concerned data item and are consistent with the approach described in the third indent of paragraph 3.2 of the Circular Letter CR/242, which stipulates: "For indicating the internal compatibility (i.e. the compatibility of a given digital broadcasting requirement of one administration with its own analogue TV assignments and/or with its own assignments of other primary services) a new data element is to be introduced. However, for indicating the compatibility of a given digital broadcasting requirement of one administration with its own digital broadcasting requirements, the administration needs to use the concept of administrative declarations."
