WORDS MATTER

Technical specifications **should whenever possible** be defined so as to take into account accessibility criteria for people with disabilities or design for all users. (article 29, 2004/18/EC)

For all procurement which is intended for use by natural persons, whether general public or staff of the contracting authority, the technical specifications **shall**, except in duly justified cases, be drawn up so as to take into account accessibility criteria for persons with disabilities or design for all users. (article 42, 2014/24/EU)

"...the technical specifications shall be determined given the needs of all users, including accessibility for persons with disabilities." (national

Systematic inclusion of accessibility

Systematic inclusion of accessibility requirements "in all public procurement agreements".

UN CRPD committee recommendation April 2014



"It is important that, at an early stage of the public procurement process, contracting authorities and entities apply **the principle of universal design**, that is, they **should think strategically** so as to ensure that products and services can be used by as many people as possible and should not exclude certain users in advance."

Web Accessibility Directive Increased demand for accessibility experts and support on how to write tenders

Universal Design - EN 17161 Accessibility Following a Design for All approach (published 2019) guidance on involvement of "non users" in needs analysis, in agile development, along end-to-end chain and in follow











Conclusions

Social considerations is an ambition, not a requirement, main focus on promoting employment for disadvantaged groups through suppliers. Sustainable focus on "green"

Guidance related to disability specific services takes up accessibility as optional, lack of mainstream guidelines

Usability in framework agreements for ICT in the work place. Does not (yet) consider excluded "non" users, Universal Design and accessibility standards.

Over the threshold €750,000 Contracting authorities are **required to...**

Contracting authorities have discretion to disqualify candidates for competing in a public procurement competition for the following reasons...

In where the contracting authority can demonstrate violations of environmental, social and labour law obligations including rules on accessibility for disabled persons
