On behalf of the International Telecommunication Union (ITU), I am pleased to invite you to participate in the workshop on "Consumer Law and Regulation in Telecommunications" for Portuguese and Spanish speaking countries in Africa, to be held in Sao Tomé and Príncipe from 18 to 21 April 2011. The workshop will be hosted by the Autoridade Geral de Regulação, AGER. The workshop is being conducted under the aegis of the ITU Centres of Excellence Network for Portuguese and Spanish speaking countries in Africa.

The workshop will provide participants with an understanding of instruments used to ensure the protection of consumer rights as well as to promote greater balance among the actors involved in the process (consumers and the regulated sector) and improve the quality of regulation.

Among others, the following topics will be covered:

- Regulator and consumer rights

The workshop will also highlight the need for the participation of consumers in the regulatory process.

This Workshop will target managerial staff from regulatory authorities, government institutions, telecommunication companies and academia, who are responsible for consumer protection and interested in understanding how to use instruments to ensure the protection of consumer rights as well as the development and implementation of consumer regulation in the telecommunication industry. Consumer Associations and Advocacy Groups on consumer rights issues are also welcome to participate in this workshop.
