On behalf of the International Telecommunication Union (ITU), I am pleased to invite you to participate in the workshop on "Conflict Resolution" for Portuguese and Spanish speaking countries in Africa, to be held in Praia, Cape Verde, from 27-29 April 2011. The workshop will be hosted by the Agência Nacional das Comunicações, ANAC, under the aegis of the ITU Centres of Excellence Network for Portuguese and Spanish speaking countries in Africa.

The workshop aims at strengthening participants' skills and confidence in facing conflicts. It also endows participants with skills to make informed decisions from a range of choices when dealing with conflict resolution.

The workshop will cover a wide range of topics on conflict resolution, from concept and identification to post conflict issues. It will also cover communication tools that can be used in conflict resolution.

The following topics will be addressed:

- Concept, identification, sources, factors and characteristics of conflicts
- Parties in the conflict
- Telecommunications and related questions
- Type of conflicts in the telecommunications industry (conflicts of interest)
- Resolving conflicts, facing the regulators, operators and consumers
- Special approach to conflicts resolution facing two or more operators
- Conflict resolution framework and case studies

This workshop will target senior executives, sales people, human resources managers, law professionals, mediators, trainers and anyone involved with negotiations and conflict resolution. However, due to the fact that the course content is at a high level, a background in law is a relevant requirement.

In order to benefit from each other's experience, participants are invited to prepare and present case studies during the workshop.

However, countries are free to send more than one participant for this workshop, as long as they meet the cost of travel, accommodation and related expenses in Cape Verde.
