On behalf of the International Telecommunication Union (ITU) and the Australian Communications Media Authority (ACMA), we would like to invite you to nominate participants for the ITU/ACMA International Training Program (ITP) for 2011. The ITP 2011 will be held in Melbourne, Australia, from 8-9 November 2011.

The ITP 2011, which has been made available through the support of the Australian Government and ITU, aims to provide a comprehensive overview and insight into Australia's contemporary converged communications regulatory environment, with a focus on the implications and challenges of convergence. The program is designed for middle and senior managers from governments across the Asia-Pacific region, and offers participants the opportunity to learn, discuss, debate and exchange ideas with communications experts and professionals from Australia and abroad.

This year's program will build on the successful format of previous years and would also focus on Regulating for the Future. The training will be conducted in English only.

The ITP 2011 is being hosted with the support of the ITU Regional Office for Asia and the Pacific. Regarding countries in the Asia-Pacific Region, ITU is pleased to inform you that we will provide one full fellowship to one participant duly authorized by the respective ITU Administrations from Least Developed Countries, and daily subsistence allowance (DSA) to one participant from Low-Income Developing Countries, subject to available budget and for full participation at this training program.
