On behalf of the International Telecommunication Union (ITU), I am pleased to inform you that the Telecommunication Development Bureau in collaboration with Odessa National Academy of Telecommunications named after A. Popov (ONAT named after A.Popov) is organizing the Regional Seminar on Costs and Tariffs of Telecommunication/ICT for CIS Countries, which will be held in Odessa, Ukraine from 24 to 26 October 2012.

This Seminar is intended for representatives from ministries, regulators, telecommunication operators, universities and other stakeholders of the ITU Member States, Sector Members and Associates from the CIS Region.

The workshop languages are Russian and English. Simultaneous interpretation from/into English will be provided.

The Seminar will be paperless.
