On behalf of the International Telecommunication Union (ITU), I am pleased to invite you to participate in the workshop on **"Business Aspects of Interconnection of Networks**" for Portuguese and Spanish speaking countries in Africa, to be held in São Tomé & Príncipe, from 2 to 5 September 2013. The workshop will be hosted by the Autoridade Geral de Regulação, AGER. It is being conducted under the aegis of the ITU Centres of Excellence Network for Portuguese and Spanish speaking countries in Africa.

This workshop aims at providing participants with the knowledge on competition in regulated national and international markets, updated with new business models like VoIP and OTT. This is also assuming greater significance in view of the recent entrance of a new global operator and the access to the submarine cable system in São Tomé. - Trends, NGN

The workshop targets commercial managers and other professionals from regulatory bodies, government institutions and operators within the electronic communications sector from portuguese and spanish speaking countries in Africa, dealing with interconnection of networks.
