Andrea Mamprim Grippa has a degree in International Relations from the University of Brasilia (UnB) with a specialization degree in Telecommunications Management from the Federal University of Rio de Janeiro. Since 2007 she has been working at the International Affairs Office of Anatel of Brazil, with a specialty in international cooperation in telecommunications/ICTs, being a focal point for issues related to the development of telecommunications, especially at the International Telecommunications Union (ITU).

She also acts in different Regional Telecommunications Associations and Organizations such as the Inter-American Telecommunications Commission (CITEL) – COM/CITEL and PCCI, Latin American Forum of Telecommunications Regulators (REGULATEL), Association of Telecommunications Regulators of Portuguese Speaking Countries (ARCTEL) and Sub-Working Group 1 (SGT-1) of Mercosur.

Since September 2024 holds the position of Head of Anatel's International Advisory Department and advises the Agency's leaders (Commissioners and Superintendents) on international issues.

Mrs. Grippa has been participating at the ITU Plenipotentiary Conferences, ITU Development Conferences, CITEL Assembly, COM/CITEL, Permanent Consultative Committee I (PCCI) of Citel, MWC, GSMA360 Latin America, Plenary Assembly of Regulatel, annual meetings of the TDAG (ITU-D), and meetings at the bilateral level (foreign regulators, embassies, ministries, sectoral companies).

She has held the following positions at International Telecommunications Organizations:

- Representative of the Americas at the ITU Group of Capacity Building Initiatives (GCFI) (2022-2024);
- Has been designated as CITEL focal point in the ITU-D Telecommunication Development Advisory Group (TDAG) Working Group for preparations for the latest ITU World Telecommunication Development Conference (WTDC-22), Kigali, Rwanda.
- During the ITU Plenipotentiary Conference in Bucharest, Romania, in 2022, she chaired the Working Group for the review of Resolution 70, which seeks to promote gender equality and empower women and girls through ICT.
- Currently, she holds the position of Coordinator of the COM/Citel Working Group for gender equity and meaningful youth empowerment.

- Currently, she holds the position of Vice-Chair of the TDAG (ITU-D) 2022-2025 and Chair of the TDAG Working Group for streamlining Resolutions for the next World Telecommunication Development Conference (WTDC-25).

At the bilateral level, she has relevant role with the regulators of Latin American countries, in technical cooperation activities and exchange of regulatory information.

She is fluent in Portuguese, English and Spanish, with knowledge of French and Italian.

She began her work activities in the ITU Regional Office for the Americas, in addition to having worked at Telemig/Telenorte Participações (telecommunication holding company in post-privatization in Brazil), in the International Department of the National Electric Energy Agency (ANEEL) and in the international area of the Federal Engineering Council (CONFEA).
