During that time, he completed a PhD examining the maternal determinants of intra-uterine bone growth as part of an ARC Clinical Fellowship at the University of Southampton followed by a travelling fellowship and worked with the OA group in UCSF to study the role of vitamin D and bone in lower limb OA.

Since his return to the UK, he has been appointed as Honorary Consultant Rheumatologist and as Associate Professor in Metabolic Bone disease at the University of Oxford. His research interests include the role of epidemiology of musculoskeletal diseases focusing on secondary fracture prevention and rare bone diseases.
