

- WSIS Targets


Outcome



Open Consultation Process



Open Consultation Process (OCP)

The WSIS+20 Forum High-Level Event is scheduled to be held from 27 to 31 May 2024, co-hosted by the Confederation of Switzerland in Geneva, with the support of remote participation. The preparatory process is an open and inclusive consultation with WSIS stakeholders (governments, private sector, civil society, international organizations and relevant regional organizations) to develop the event programme, collecting inputs to identify gaps in the implementation of Geneva Plan of Action and the WSIS Action Lines, and contribute to the overall review of the implementation of WSIS+20 outcomes by the UN General Assembly in 2025. The UN General Assembly's (UNGA80) overall review of WSIS+20 outcomes is also expected to help, shape the vision of WSIS beyond 2025, and this preparatory process will also serve as a platform to provide input to that process.

All stakeholders are encouraged to actively engage in the OCP by participating in consultative meetings and submitting input through the official submission form.


