Digital tool to enhance right of access to land information

On the Right of Access to Information

What is the Right of Access to Information (RTI)?

- A fundamental human right that allows people to seek, receive, and share information from public bodies
- An integral part of the fundamental right of freedom of expression, as recognized by Article 19 of the Universal Declaration of Human Rights (1948), which states that the fundamental right of freedom of expression encompasses the freedom to "to seek, receive and impart information and ideas through any media and regardless of frontiers"
- A universal right: recognized 28 September as the International Day for Universal Access to Information at the 74th UN General Assembly in October 2019

On the Right of Access to Information

How is RTI protected & regulated?

Globally:

 137/193 UN member countries have laws regulating access to information

Different names (with varying implications):

- Access to information (ATI)
- Freedom of information (FOI)
- Right to information (RTI)

The latest country to adopt: Zambia in 2023

Regionally:

In ASEAN, as a constitutional right: Indonesia; Lao PDR; Malaysia; Philippines; Thailand; Timor-Leste; Viet Nam

On the Right of Access to Information

Case study from Vietnam

Recognized as a constitutional right in 2013 Constitution (Article 25)

 "The citizen shall enjoy the right to freedom of opinion and speech, freedom of the press, of access to information, to assemble, form associations and hold demonstrations. The practice of these rights shall be provided by the law"

Protected with substantive and procedural regulations

- Law on access to information (2016)
 Imbedded and cited in other provisions
- Land Law (2024); Law on implementation of grassroots-level democracy (2022); Law on environmental protection (2020)

Youth Declaration: Harnessing AI and ICT for a Sustainable Future

WSIS Forum 2025 | Geneva, 7 July 2025

We, the youth of the digital era, stand at a pivotal moment in history. Facing urgent climate crises, widening inequalities, and evolving technological landscapes, we declare our commitment to leverage artificial intelligence (AI) and information and communication technologies (ICT) as catalysts for achieving the Sustainable Development Goals (SDGs), Implied by the legacy of WSIS and aligned with the Global Digital Compact (GDC), we call for united action across three dimensions:

1. Digital Empowerment for Planetary Resilience

Aligned with WSIS Action Line CI1 (International Cooperation), SDG 13 (Climate Action), and GDC Objective 3 (Digital Governance)

We commit to harnessing Al-driven solutions to accelerate climate mitigation and adaptation. We demand inclusive platforms where young innovators co-design policies and deploy ICT tools—from predictive climate models to sustainable energy systems ensuring intergenerational equity and resilience.

2. Revolutionizing Education for Equity

Aligned with WSIS Action Line CI (Digital Literacy), SDG 4 (Quality Education), and GDC Objective 2 (Digital Inclusion)

We advocate for ICT-enabled Education for Sustainable Development (ESD) as a correctione of global curricula. We urge governments to:

- Train educators in Al and digital pedagogies to foster sustainability competencies (e.g., systems thinking, critical innovation).
- Integrate localized ESD frameworks—such as cross-cultural fables and challenge-based learning—to bridge socio-emotional and cognitive development.
- Ensure gender-equal access to digital tools, dismantling barriers that exclude girls and marginalized youth.

3. Co-Creating Inclusive Digital Governance

•Aligned with WSIS Action Line C7 (E-Government), SDG 17 (Partnerships), and GDC Objective 1 (Digital Connectivity)+

We demand seats at decision-making tables! Drawing from the G20's roadmap for

authentic youth engagement, we call for:

- Lowering age barriers in policy forums (per OECD 2020) and establishing youth advisory councils.
- · Scaling participatory digital platforms to crowdsource youth-led SDG solutions.
- Mobilizing cross-sector partnerships—governments, academia, and civil society—to fund and amplify ICT-for-good initiatives.

- Develop open-source AI tools addressing local sustainability challenges.
- Map digital innovation hubs advancing SDG 4, 13, and 17.
