



COMPLETE PACKAGE TO DISASTER REDUCTION

The Mitigation Onion Layer Approach (MOLA)

1. Early Warning -Focus on Universal Access to ICTs -Facilitate Timely Dissemination of Information

3. Preparedness Early warning + temporary measures

4. Risk Management Policies, strategies + practices aimed at disaster risk reduction

2. Prevention

Raising awareness using ICTs and building preventive measures in projects
