1) Subclause 2.4.2.3

In subclause 2.4.2.3, replace:

Complete Transport Stream packets containing system information, for the program selected for decoding, enter the system transport buffer, TB_{sys} , at the Transport Stream rate. These include Transport Stream packets whose PID values are 0 or 1, and all Transport Stream packets identified via the Program Association Table (see Table 2-25) as having the `program_map_PID` value for the selected program. Network Information Table (NIT) data as specified by the NIT PID is not transferred to TB_{sys} .

with:

Complete Transport Stream packets containing system information, for the program selected for decoding, enter the system transport buffer, TB_{sys} , at the Transport Stream rate. These include Transport Stream packets whose PID values are 0, 1 and 2 (if present), and all Transport Stream packets identified via the Program Association Table (see Table 2 25) as having the `program_map_PID` value for the selected program. Network Information Table (NIT) data as specified by the NIT PID is not transferred to TB_{sys} .
