## FOREWORD

## TECHNICAL CORRIGENDUM 2

**1) Subclause 7.2.11**

*Remove the last sentence of the first paragraph.* (This attribute has no effect if any generic layout or generic logical structure is present in the document.)

**2) Subclause 7.3.2**

*Add a new paragraph after the third paragraph as follows:*

Specifications of the presentation attributes and coding attributes for external content architectures, for which a document application profile may also define non-standard default values, may be given in specifications other than ITU-T Rec. T.410-Series | ISO/IEC 8613.

**3) Subclause 7.3.8.5**

*In the bullet list in the second paragraph, replace:*

- “geometric graphics coding attributes”.

*by:*

- “geometric graphics coding attributes”;
- “external content architecture coding attributes”.

**4) Subclause 7.3.8.6**

*In the bullet list in the third paragraph, replace:*

- “geometric graphics presentation features”.

*by:*

- “geometric graphics presentation features”;
- “external content architecture presentation features”.
