# **Summary**

The point of this amendment is to direct the readers of Recommendation ITU-T G.984.4 to consult Recommendation ITU-T G.988 as their primary reference. That said, Recommendation ITU-T G.984.4 remains "in-force" for those features that are not covered in Recommendation ITU-T G.988.

# 1 Scope

The point of this amendment is to direct the readers of Recommendation ITU-T G.984.4 to consult [ITU-T G.988] as their primary reference. That said, Recommendation ITU-T G.984.4 remains "in-force" for those features that are not covered in [ITU-T G.988].

# 2 Changes to ITU-T G.984.4 (2008)

# 2.1 Modification to "Summary"

*Replace the summary with the following:* 

"The most up-to-date specification for the ONT management and control interface (OMCI) now appears in Recommendation ITU-T G.988. Readers with a continuing interest in OMCI are advised to consult Recommendation ITU-T G.988 as their primary reference.

Recommendation ITU-T G.988, the generic OMCI specification, is intended to cover a variety of access systems, including G-PON. However, Recommendation ITU-T G.988 does not document all of the legacy features that were contained in Recommendation ITU-T G.984.4. Definitions and features contained in Recommendation ITU-T G.984.4 that do not appear in Recommendation ITU-T G.988 remain valid for legacy ITU-T G.984 applications. Further, all code points assigned to such legacy definitions remain reserved and are excluded from the code points assignable by Recommendation ITU-T G.988."

# 2.2 Modification to clause 1, Scope

Add the following text to the beginning of clause 1:

"The most up-to-date specification for the ONT management and control interface (OMCI) now appears in [ITU-T G.988]. Readers with a continuing interest in OMCI are advised to consult [ITU-T G.988] as their primary reference. For items where Recommendation ITU-T G.984.4 (2008, as amended) and [ITU-T G.988] conflict, [ITU-T G.988] takes precedence. However, for legacy items specified by Recommendation ITU-T G.984.4, where [ITU-T G.988] remains silent, then the Recommendation ITU-T G.984.4 material remains in force. Further, all code points assigned to such legacy definitions remain reserved and are excluded from the code points assignable by [ITU-T G.988]."

# 2.3 Modification to clause 2, References

Add the following reference to clause 2.

[ITU-T G.988] Recommendation ITU-T G.988 (2010), *ONU management and control interface (OMCI) specification*.
