## Support for 14 kHz audio bandwidth extension of G.722.1 Annex C in H.242

#### Summary

This amendment adds the BAS code signalling and H.221 multiplex allocation to support Annex C/G.722.1 (14 kHz audio bandwidth extension of the G.722.1) in H.320 systems.

#### Source

Amendment 1 to ITU-T Recommendation H.242 (2004) was approved on 13 September 2005 by ITU-T Study Group 16 (2005-2008) under the ITU-T Recommendation A.8 procedure.

#### FOREWORD
