# **Upgrade to MTNM Release 3.5**

#### **Summary**

The current in-force ITU-T M.3170.x series of Recommendations provides the MTNM solution suite v3.0 from TM Forum. A newer version of MTNM has been applied across the industry (e.g., Release 3.5). In order to support conformance testing for this series of Recommendations within ITU-T, Amendment 1 to Recommendation ITU-T M.3170.2 (2007) provides the upgraded information from MTNM v3.0 to MTNM release 3.5, including updated references to TMF Release 3.5-related specifications. More detailed updates will be provided while upgrading to TMF MTNM Release 4.0 or 4.5 when it is more stable and fully supported by the industry.
