FOREWORD

The International Telecommunication Union (ITU) is the United Nations specialized agency in the field of telecommunications. The ITU Telecommunication Standardization Sector (ITU-T) is a permanent organ of ITU. ITU-T is responsible for studying technical, operating and tariff questions and issuing Recommendations on them with a view to standardizing telecommunications on a worldwide basis.

1) Clause 6 – Signalling parameters

Modify clause 6 as follows and renumber all subsequent subclauses accordingly:

.....

6.4 automatic congestion level: Information sent to the node to indicate that a particular level of congestion exists at the sending node.

6.5 automatic re-routing: Information sent in either direction giving information about automatic re-routing of a call.

6.56 backward call indicators: Information relating to the characteristics of the connection, signalling path and called party sent in the backward direction.

2) Clause 7 – Parameter information

Modify clause 7 as follows and renumber all subsequent subclauses accordingly:

.....

7.151 release call indicator: Information sent to inform another node to release the call or not, by compatibility reasons, if the related message or parameter is unrecognized.

7.152 re-routing counter: Information indicating the number of invocations of re-routing that a call has undergone.

7.153 re-routing inhibit indicator: Information indicating whether the call is allowed to be re-routed.

7.154 re-routing reason: Information indicating the reason why automatic re-routing has been invoked.

7.152155 return to invoking exchange call identifier: Information used by the return to invoking node function to identify a call.
