#### FOREWORD

The International Telecommunication Union (ITU) is the United Nations specialized agency in the field of telecommunications. ## **ITU-T Recommendation Q.762**

### Amendment 2

#### 1) Clause 3 – Signalling parameters

Add the following definition to clause 3:

**3.101 automatic re-routing**: Information sent in either direction giving information about automatic re-routing of a call.

#### 2) Clause 4 – Parameter information

Add the following definitions to clause 4:

**4.158 re-routing counter**: Information indicating the number of invocations of re-routing that a call has undergone.

**4.159** re-routing inhibit indicator: Information indicating whether the call is allowed to be rerouted.

**4.160** re-routing reason: Information indicating the reason why automatic re-routing has been invoked.
