## **Recommendation ITU-T Q.1912.5 D**

### **Interworking between session initiation protocol (SIP) and bearer independent call control protocol (BICC) or ISDN user part (ISUP): Test suite structure and test purposes (TSS&TP) for profile C**

#### **Summary**

Recommendation ITU-T Q.1912.5 D specifies the test suite structure and test purposes (TSS&TP) for interworking between session initiation protocol (SIP) and bearer independent call control protocol or between SIP and ISDN user part for the profile C described in Recommendation ITU-T Q.1912.5.

#### **Source**

Recommendation ITU-T Q.1912.5 D was approved on 14 October 2008 by ITU-T Study Group 11 (2005-2008) under Recommendation ITU-T A.8 procedures.

## FOREWORD

The International Telecommunication Union (ITU) is the United Nations specialized agency in the field of telecommunications, information and communication technologies (ICTs). ## **Recommendation ITU-T Q.1912.5 D**

### **Interworking between session initiation protocol (SIP) and bearer independent call control protocol (BICC) or ISDN user part (ISUP): Test suite structure and test purposes (TSS&TP) for profile C**

#### **1 Scope**

This Recommendation specifies the test suite structure and test purposes (TSS&TP) for interworking between session initiation protocol (SIP) and bearer independent call control protocol or between SIP and ISDN user part for the profile C described in [ITU-T Q.1912.5].

Other Recommendations of the ITU-T Q.1912.5 family specify the network protocol implementation conformance statement (PICS) proforma, the test suite structure and test purposes (TSS & TP) for profiles A and B, and the abstract test suite (ATS) and partial protocol implementation extra information for testing (PIXIT) for profiles A and B.
