## Support for the customized alerting tone (CAT) service

#### **Summary**

Amendment 6 to Recommendation ITU-T Q.763 was produced to meet the need for the implementation of the customized alerting tone (CAT) service as specified in ETSI TS 123.205 (2009). This amendment contains the modifications to Recommendation ITU-T Q.763 (1999) in order to accommodate these needs. This amendment should be read in connection with the related amendments to Recommendations ITU-T Q.761 and ITU-T Q.762.

#### **Source**

Amendment 6 to Recommendation ITU-T Q.763 (1999) was approved on 29 October 2009 by ITU-T Study Group 11 (2009-2012) under Recommendation ITU-T A.8 procedures.

#### **FOREWORD**

The International Telecommunication Union (ITU) is the United Nations specialized agency in the field of telecommunications, information and communication technologies (ICTs). The ITU Telecommunication Standardization Sector (ITU-T) is a permanent organ of ITU.   - 11 Spare




Figure 99 – Backward customized alerting tone parameter field
