Summary

Amendment 3 to Recommendation ITU-T Q.1902.1 was produced to meet the need for the implementation of the customized alerting tone (CAT) service as specified in ETSI TS 123.205 (2009). This amendment contains the modifications to Recommendation ITU-T Q.1902.1 (2001) needed to accommodate these needs. This amendment should be read in connection with the related amendments to Recommendations ITU-T Q.1902.2 and ITU-T Q.1902.3.

FOREWORD
