#### **HIGHLIGHTS**

Turkey is one of the founding members of ITU and a contributing country since 1865. As a Member Country of the ITU Council continuously since 2002, Turkey has actively participated in and contributed to the work of the Council in close collaboration with all ITU Member States as well as the ITU management.

Turkey is also among the founder members of the UN, OECD, OIC, Council of Europe, OSCE, ECO, BSEC and G-20 Major Economies and is strongly committed to the values and principles that are shared by the international community.

Thanks to her unique position at the crossroads of three continents, Europe, Asia and Africa, Turkey serves as a bridge between various cultures and civilizations. Turkey's central location also allocates her the responsibility to connect the developing and the developed world to each other.

Turkey's Strategic Vision of 2023 sets very important goals, which attach special importance to ICTs as an accelerator for the achievement of the UN's 2030 Agenda for Sustainable Development and the SDGs. These goals include expanding the economy to rank among the global top ten; transformation to knowledge-based society; building an intercontinental hub for ICTs; providing an ICT-based economic growth, enhancing high speed broadband access for all.

In line with that vision, Turkey continues to taking strong steps in order to create a fully transformed digital economy and society through affordable and accessible ICTs. The IMT-Advanced auction held in 2015 represented an important milestone for Turkey's transition to 5G. Operators started to provide IMT-Advanced services since the beginning of April 2016 enhancing further the value added mobile services and applications in Turkey.



## **TURKEY IN NUMBERS**AS 0F 2017

- ▶ There are 451 operators providing service in the ICT market with 801 authorizations
- Total investments of mobile network operators are 15.96 in the year 2015, 5.72 in the year 2016 and 4.04 billion TL's for 2017.
- Mobile traffic volume is 256.7 billion minutes and fixed traffic volume is 7.6 billion minutes in 2017.
- There are 11.31 million fixed telephony subscribers and penetration rate is 14.2 % \*
- The number of broadband subscribers, which was 6 million in 2008, has reached 68.87 million.
- ▶ The number of xDSL subscribers is realized as 8.7 million.
- ▶ The number of mobile broadband subscribers is around 57 million.



- ▶ The number of cable internet subscribers reached to 827k.
- 8.3 million of fixed broadband subscribers in Turkey prefer 10-30 Mbps download speeds.
- 432k users connecting to mobile internet via computer have a data usage of 1 Gb and above.
- There are almost 77.80 million mobile subscribers corresponding to 96.30 % penetration rate.
- Number of 4.5 subscribers has reached to 64.56 million.
- As of 2017, total number of ported numbers reached to 112.3 million.
- M2M subscribers has reached to almost 4.5 million.
- Fiber optic length reached to 324.667 km.
