3. Request for cooperation

In order to get the ITU-T decision of applying Resolution No.1 to the two Recommendations, members of ITU-T Experts Group and MPEG are requested of the following.

1) Comments for the DIS version

The "Guide for ITU-T and ISO/IEC JTC1 cooperation (March 1993)" stipulates the final stage of the standardization work as follows;

- Responses from National Bodies of JTC1 and ISO/IEC to the DIS ballot are collected by the ITTF and distributed in a Summary of Voting Report by the SC secretariat. ITU-T members will comment by means of contributions to the SG. Both sets of response are to be made available to each of the two working level groups.
- The DIS ballot responses and the comments from ITU-T members will be considered as the DIS ballot resolution meeting. With ITU-T participation, the group reviews and resolves the comments and negative ballots.

The November meeting should be operated accordingly.

2) Delta between DIS and IS

ITU-T meeting in February 1995 needs this delta document as well. Hence the November work should make this possible.

3) Patent licensing policy statement and advice of relevant patent information

The action for ITU-T Rec. H.262IISO/IEC 13818-2 (Video) is ongoing as summarized in the companion document AVC-670. This should be completed. Furthermore the same action should be taken for ITU-T Rec. H.222.0IISO/IEC 13818-1 (Systems).

Full support of ITU-T and ISO/IEC JTC1 members are requested.
