I have the pleasure to inform you that, at the kind invitation of the Ministère des Technologies de la Communication en Tunisie, the ITU-D Regional Development Forum on “Access to spectrum, including broadcasting services – trends and technologies” will be held on 1 – 3 June 2009 in Tunis (Tunisia) jointly organized by ITU and the Agence Nationale des Fréquences (ANF), Tunisia.
