**Subject: Sub-regional workshop on Digital Television Migration and Digital Dividend  
Montevideo (Uruguay), 30 May to 1 June 2012**

The International Telecommunication Union (ITU) and the Regulatory Unit of Communications Services (URSEC) are pleased to invite your organization to participate in a sub-regional workshop on the transition to digital television and the digital dividend that will take place from May 30 to June 1, 2012 in Montevideo. This South American event in nature, with the sponsorship of the National Telecommunications (DINATEL) and the National Telecommunications Administration (ANTEL), will cover important aspects concerning the challenges of both industry and governments in the coordination processes of the transition to digital television broadcasting and the allocation of digital dividend in the region.
