Subject: Update on preparations for the Fifth World Telecommunication/ICT Policy Forum (WTPF-13)

and the Strategic Dialogue

Dear Sir/Madam,

Further to my letter DM-12/1024, I am pleased to inform you that preparations are advancing well for the forthcoming World Telecommunication/ICT Policy Forum (WTPF-13) and Strategic Dialogue, which will be held in the Centre International de Conférences Genève (CICG), in Geneva, Switzerland on 13-16 May 2013.

Strategic Dialogue

In accordance with past practice, a Strategic Dialogue will be held on the day before the opening of the WTPF-13, Monday, 13 May 2013, from 14.30-18.00 in the CICG. High-level speakers will address the theme of "Building our broadband foundations for the future". The detailed programme is available at http://www.itu.int/go/wtpf-13/dialogue.

Fifth WTPF

This global Forum provides a venue for discussing strategies and policies of high current policy interest in the changing telecommunication environment, with non-binding outcomes. The WTPF-13 will allow an exchange of views on international public policy issues pertaining to the Internet. WTPF-13 shall not produce prescriptive regulatory outcomes; however, it shall prepare reports and adopt opinions by consensus for consideration by Member States, Sector Members and relevant ITU meetings. As with previous Forums, the WTPF will be open to Member States and Sector Members. The public and the media are also invited to attend. Report by the Secretary-General

The Informal Experts Group held its last meeting on 6-8 February 2013. It reviewed the comments on the fourth draft of the Secretary-General's Report and agreed by consensus on the following six draft opinions to be included in the final version of the Report.

Opinion 1	Promoting Internet Exchange Points (IXPs) as a long-term solution to advance connectivity
Opinion 2	Fostering an enabling environment for the greater growth and development of broadband connectivity
Opinion 3	Supporting Capacity Building for the deployment of IPv6
Opinion 4	In Support of IPv6 Adoption and Transition from IPv4
Opinion 5	Supporting Multistakeholderism in Internet Governance
Opinion 6	On supporting operationalizing the Enhanced Cooperation Process

Documentation

The WTPF-13 will be conducted in a paperless manner to the greatest extent possible. Participants are invited to bring their laptop PCs with them to work at the Forum. Documentation will be made available on the website of the Forum. To respond to Decision 5 (Rev. Guadalajara, 2010) and proposed measures for reducing expenditure, a maximum of two paper sets of all documents will be made available, upon request, to Member States and Sector Members at the Forum venue. Delegations wishing to receive documentation are invited to submit their requests to sg-registration@itu.int by 29 April 2013.

Comments by the membership on the Secretary-General's Report during the Forum

Member States and Sector Members will have an opportunity to make additional comments on the Secretary-General's Report at the Forum, in particular with regard to the review and adoption of the Forum Opinions. In order to ensure the timely translation and thorough consideration by delegations, written contributions to be presented during the Forum should be sent to wtg2013@itu.int by 29 April 2013. It is strongly recommended that contributions do not exceed three pages.

Subject to the availability of funds, participants from Least Developed Countries (LDCs) and countries with a GDP per capita less than 2,000 USD (with priority to LDCs) may apply for a partial fellowship if duly authorized by his/her administration. Two partial fellowships per eligible Member State and Sector Member will be awarded on a first-come, first-serve basis.
