Note from the TSB

In the TSB Circular 230 of 19 July 1996, TSB communicated the timetable and other advance information concerning the inauguration of Universal International Freephone Numbers (UIFN) for the international freephone service*. At present about 19 000 UIFN numbers have been assigned to international freephone service customers.

A Universal International Freephone Number (UIFN) enables an international freephone service customer to be allocated one or more freephone numbers which will be valid throughout the world and unique. An UIFN number is composed of a three-digit country code for a global service application, 800, and a global subscriber number of 8 digits (ITU-T Recommendation E.169 (11/98), section 3.9). An international freephone service caller who places a call to a UIFN number must dial an international prefix prior to the UIFN number and the call is free to the caller. Example +800 XXXXXXXX.

TSB has prepared a list of applicants – service provider, recognized operating agency (ROA) as defined in the Annex to the Constitution (Geneva, 1992), or national administration – which have submitted an application for a global subscriber number on behalf of the international freephone service customer (ITU-T Recommendation E.169 (11/98), section 3.2). The first list is published in the current ITU Operational Bulletin (No. 718 of 15.VI.2000), in the section "Amendments to service documents".

**Bureaufax Service
ITU-T Recommendation F.170 (03/98)**

Bureaufax Table

Note from the TSB

The Bureaufax Table* is now available on the Internet at <http://www.itu.int/itu-t/bureaufax> to facilitate access by all telecommunication and postal Administrations. It is now published in electronic version *only* so as to take account of the frequent changes of facsimile numbers and make them immediately available to all administrations. With this new means of communication, the information will be most valuable to the users. Amendments to the Bureaufax Table in the electronic version will continue to be published in the Operational Bulletin (<http://www.itu.int/itu-int/bulletin>).

Due to frequent changes in the names of countries/geographical areas with which the international Bureaufax service is open, it had become very difficult to maintain accurate information in PART I of the Bureaufax Table. It is for this reason that PART I of the Bureaufax Table (4th edition) no longer appears in the electronic version. Please note also paragraph 11 of ITU-T Recommendation F.170, in which it is mentioned that the number of gateway bureaux (PART III of the Bureaufax Table) must be kept to a reasonable limit.

Telecommunication and postal administrations are requested to verify their data which appear in the Bureaufax Table on the Internet and to communicate to ITU any new or modified information by using the Notification Form in the Bureaufax Table homepage. It is in everyone's interest that the information be kept up-to-date by immediate notification concerning the Bureaufax Table.

Please note that the data of the electronic version of the Bureaufax Table are in three languages and the countries are listed in French alphabetical order of name of countries/geographical areas.

Telegram Service

New Zealand

Communication of 1.VI.2000:

Cessation of telegram service Replacement services

The Administration of New Zealand announces that The Telegram Company of New Zealand Post Limited, Wellington, will cease to provide the international telegram services from and to New Zealand (telegram destination indicator NZ) as from Monday, 3 July 2000.

The Electronic Business unit of New Zealand Post, Wellington, will continue to provide international communication services to transmit and receive international communications as follows:

- *Outgoing from New Zealand*

FaxLink: New Zealand Post can send messages to a private fax machine almost anywhere in the world, or to an International Fax Bureau. The fax message can then be delivered by mail, courier (for an additional fee) or be collected from the International Fax Bureau.

International Postal Services (message delivery)

- International express – fast and secure delivery to large towns in a few days, Track and Trace from pick-up in New Zealand to signature delivery overseas.
- International air – delivery to large towns in approximately one week;
- International economy – delivery to large towns in approximately 3 weeks.

- *Incoming to New Zealand*

FaxLink: An individual can receive a fax message from a private fax machine by having it sent to their nearest Post Shop for collection. A handling fee is charged upon collection.

Alternatively, messages can be faxed from overseas to three locations (Auckland, Wellington and Christchurch) where, upon receipt, they will be forwarded on in the mail (the message received, will be enveloped and forwarded by mail):

- *Customer service centres – Hours of service*

New Zealand post shops are open from 0830 to 1730 hours. Customer service centres are open for calls, as follows:

0730 to 1930 hours Monday to Friday
0900 to 1300 hours Saturday

At all other times, there is an "After Hours Call Centre" which can give information but cannot resolve queries. Telephone number: 0800 501 501.

FaxLink: All post shops with fax machines (over 160) are accepting offices for FaxLink, for international messages that need to be delivered onwards by mail.

List of countries/geographical areas accepting offices for international FaxLink messages: Germany, Netherlands Antilles, Argentina, Bahamas, Brazil, Canada, China, Cyprus, Korea (Rep. of), Denmark, Egypt, Spain, Fiji (Suva), France, Gibraltar, Greece, Greenland (via Denmark), Ireland, Iceland, Israel, Italy, Japan, Luxembourg, Macau, Malaysia, Maldives, Nauru, Norfolk Island, Norway, Papua New Guinea, Netherlands, Philippines, French Polynesia, Portugal, Qatar, United Kingdom, Singapore, Sweden, Switzerland, Taiwan, Tonga, Trinidad and Tobago.

The FaxLink service is a fast, convenient and more economic alternative to sending telegrams. New Zealand Post is also in the process of extending the FaxLink network to include more accepting countries, and for developing some new and exciting electronic communication services. More details will be given as and when these products become available.

Barbados

Communication of 25.V.2000*:

Cable and Wireless BET Ltd., Bridgetown, announces that the telephone numbering plan for Barbados is as follows:

- All central office codes (NXX) are three digits and subscriber numbers (XXXX) four digits.
- Barbados is in the World Zone 1 area (country code +1) and the Numbering Plan Area (NPA) code is 246. Differentiation is made by the applicable central office codes within the area of the 246 NPA code.
- The trunk codes (NXX's) for Barbados are as follows:
220-239 inclusive, 292, 367, 417-439 inclusive, 444, 467, 555, 736, 737, 753 and 936.
- The trunk codes (NXX's) 230-234 are allocated to mobile radiocommunication services.

- The dialling format for the NPA code 246 is as follows:
 - All home NPA (HNPA) calls will be dialled on a seven digit basis with no prefix, i.e:
NXX XXXX (seven digits).
 - All foreign NPA (FNPA) direct dialled calls will be dialled with a prefix "1" and ten digits, i.e:
1 FNPA NXX XXXX (1 and ten digits).
- Operator assisted calls including credit card, collect and third party calls, will be dialled with a prefix "0" and ten digits, i.e:
0 NPA NXX XXXX (0 and ten digits).
