This meeting will provide Sector Members the opportunity to network and enter partnerships with multi-stakeholders from the public and private sectors, identify issues of common interest and explore potential initiatives for the benefit of ITU-D membership.

The objective of CRO WG-DFI is to align key stakeholders towards a formal commitment under the Universal Financial Access 2020 objective. The Group discusses approaches to achieve the "Universal Financial Access 2020", legal and regulatory frameworks and pilot implementation in selected countries, based on multi-stakeholder expressed commitments.
