I would like to invite you to the *ITU International Satellite Symposium 2016: "Satellite Regulation, Market, Technology Trends and Industry Opportunities"*, which will take place on 7-8 September 2016 in Denpasar, Bali, Indonesia. The Symposium will be preceded by a one-day *ITU Workshop on the Efficient Use of the Spectrum/Orbit Resource* to be held at the same venue on 6 September 2016. Hence the Symposium provides an excellent opportunity for dialogues among multi-stakeholders in public and private sectors.
