



### Project:

- E-waste management plan for Phnom Penh, Cambodia (2009)
  - Development of an inventory of E-waste, based on trade value chain.
  - Development of a management system for E-waste including identification of technologies for recovery of useful materials.

### Policy dialogue:

- Regional multi-stakeholder policy dialogue on E-waste management (18-20 July, 2012)
  - Between Governments, private sector, intergovernmental organizations, academia and public interest groups
  - The outcome document "The Future WEEE Want" was submitted to the African Ministerial Conference on the Environment
